CALL TO ORDER, ROLL CALL, PLEDGE OF ALLEGIANCE - Mayor Pro-Tem Bennett convened the meeting at 12 noon. Roll call was taken. A quorum was present although Mayor Masayko had not yet arrived. City Manager Berkich lead the Pledge of Allegiance.

CITIZEN COMMENTS (1-0013) (1-0138) - None.

Mayor Masayko arrived--12:03 p.m. The entire Board was present, constituting a quorum. Mayor Pro-Tem Bennett turned the gavel over to Mayor Masayko.

A. REVIEW AND ACTION ON A RESOLUTION AUTHORIZING EXPENDITURES OF FUNDS TO NON-PROFIT ORGANIZATIONS FOR FISCAL YEAR 1999-2000 (1-0019) - Supervisor Livermore moved that the Board of Supervisors adopt Resolution No. 1999-R-25, A RESOLUTION AUTHORIZING EXPENDITURES OF FUNDS TO NON-PROFIT ORGANIZATIONS FOR FY 1999-2000. Supervisor Williamson seconded the motion. Discussion noted the reason the Conservation District is not among the list of non-profit organizations. Its funding is provided in the other budget documents. Motion carried 5-0.

B. REVIEW AND ACTION ON SIERRA FOREST FIRE PROTECTION DISTRICT FINAL BUDGET FOR FISCAL YEAR 1999-2000 (1-0043) - Supervisor Williamson moved to approve the Sierra Forest Fire Protection District Budget for Fiscal Year 1999-2000 which adds ten cents to the ad valorem rate. Supervisor Plank and Mayor Masayko seconded the motion. Motion carried 5-0.

C. REVIEW AND ACTION ON A RESOLUTION SETTING COUNTY COOPERATIVE EXTENSION TAX RATE FOR FISCAL YEAR 1999-2000 (1-0054) - Supervisor Plank moved to adopt Resolution No. 1999-R-26, A RESOLUTION SETTING THE TAX RATE FOR COUNTY COOPERATIVE EXTENSION FOR FISCAL YEAR 1999-2000. Supervisor Livermore seconded the motion. Motion carried 5-0.

D. REVIEW AND ACTION ON CARSON CITY FINAL BUDGET FOR FISCAL YEAR 1999-2000 (1-0069) - Both Finance Director Heath and Mayor Masayko referenced a Mr. Heath's memorandum which purportedly outlined the differences between the tentative and final budgets. (The Clerk did not have a copy of this memorandum.) Supervisor Plank moved to approve the Carson City Final Budget for Fiscal Year 1999-2000. Supervisors Williamson and Bennett seconded the motion. Motion carried 5-0.

E. REVIEW AND ACTION ON TRI-COUNTY RAILWAY FINAL BUDGET FOR FISCAL YEAR 199-2000 (1-0090) - Mayor Masayko explained the reasons the Board reviews this Budget. Supervisor Plank moved to approve the Tri-County Railway Final Budget for Fiscal Year 1999-2000. Supervisor Livermore seconded the motion. Motion carried 5-0.

F. REDEVELOPMENT AUTHORITY (1-0105) - Mayor Masayko then recessed the Board of Supervisors

G. REVIEW AND ACTION ON REDEVELOPMENT AUTHORITY FINAL BUDGET FOR FISCAL YEAR 1999-2000 (1-0125) - Supervisor Livermore moved that the Board of Supervisors approve the Carson City Redevelopment Authority Final Budget for Fiscal Year 1999-2000 as presented. Supervisor Plank seconded the motion. Motion carried 5-0.

There being no other matters for consideration, Supervisor Livermore moved to adjourn. Supervisor Plank seconded the motion. Motion carried 5-0. Mayor Masayko adjourned the meeting at 12:10 p.m.
